Key Topics Covered in the Exam

A strong **Series 65 Exam Study Guide** will break the content into four major content areas. Knowing the weight of each helps you allocate study time

wisely:

1. **Economic Factors and Business Information (15%)** — Includes monetary policy, fiscal policy, economic indicators, business cycles, and analytical measures like GDP, inflation, and interest rates.
2. **Investment Vehicle Characteristics (25%)** — Covers stocks, bonds, mutual funds, ETFs, options, annuities, and alternative investments. You must understand risk, return, liquidity, and suitability.

1940, state securities acts, fiduciary duty, recordkeeping, advertising rules, and conflicts of interest.

Notice that the legal and regulatory portion accounts for nearly a third of the exam. Many candidates underestimate the nuance of these rules, so a dedicated review of state-specific regulations (especially for your state) is critical.

Creating an Effective Study

Plan

Begin by assessing your baseline knowledge. Take a diagnostic test without any preparation to see where you stand. Then, set a study schedule of at least 6 to 8 weeks, dedicating 10–15 hours per week. Consistency matters more than cramming. Your study guide should be a living document that you update as you learn.

Focused Review of Laws and Regulations

This section often trips up candidates because it requires remembering specific rules about advertising, contracts, fees, and client communications. For instance, you must know when a client can

cancel an advisory contract (five business days after signing), what information must be included in Form ADV Part 2A (brochure), and the restrictions on performance advertising (cannot imply that past performance guarantees future results).

A good **Series 65 Exam Study Guide** will highlight the differences between the Investment Advisers Act of 1940 (federal) and state laws. Even if you only practice in one state, the exam tests both. Pay special attention to:

- **Fiduciary duty:**
The highest standard of care. It includes the duty of loyalty

and the duty of care. You must always put client interests first.

- **Disclosure requirements:** Any material conflict of interest must be disclosed to clients before the advisory relationship begins.
- **Recordkeeping:** Books and records must be kept for at least five years, with certain documents available for immediate inspection.
- **Brochure delivery:** Form ADV Part 2A must be delivered to clients at the start of the relationship and

annually thereafter.

Investment Vehicles and Strategies – Deep Dive

You don't need to be an expert stock picker, but you must understand how different investments behave and which ones are suitable for different client profiles. For example:

- **Equities:** Know the difference between

common and preferred stock, including rights, privileges, and risk levels.

- **Fixed income:** Understand bond yields, duration, credit risk, and the relationship between interest rates and bond prices.
- **Mutual funds and ETFs:** Be familiar with net asset value (NAV), expense ratios, load vs. no-load funds, open-end vs. closed-end funds, and how ETFs trade intraday.
- **Options:** The exam covers basic options strategies (calls, puts, covered calls, protective puts) but not

complex spreads.

Focus on the rights and obligations of each party.

- **Alternative investments:** Real estate, hedge funds, private equity, and commodities. Know why they are used for diversification and the liquidity concerns.

For portfolio management, the study guide should explain modern portfolio theory (MPT), the efficient frontier, capital market theory, and the Capital Asset Pricing Model (CAPM). You should be able to answer scenario-based questions such as “Which asset would improve diversification for a client with a high

correlation to the S&P 500?”

Economic Factors and Business Information

This part is more straightforward than the regulation section. You need to recall the Federal Reserve’s tools (open market operations, discount rate, reserve requirements) and how they influence the economy. Understand the types of fiscal policy (expansionary vs. contractionary) and their effects on

employment, GDP, and inflation. Know the phases of the business cycle (expansion, peak, contraction, trough) and which investments perform best in each phase. For example, defensive stocks (utilities, consumer staples) are favored during recessions.

Also, be aware of key economic indicators: leading (stock market, building permits), lagging (unemployment rate, corporate profits), and coincident (industrial production, personal income). The exam may ask you to interpret a set of data to determine whether the economy is growing or slowing.

Test- Taking Strategies for the Series 65
