- **Certifying Copies:** Hawaii notaries can certify copies of documents that are not public records (e.g., a birth certificate cannot be certified by a notary; you must get that from the state department of health).
- **Protecting the Record:** Maintaining a detailed notary journal (also known as a record book) of all notarial acts performed.

ELIGIBILITY REQUIREMENTS FOR BECOMING A HAWAII NOTARY PUBLIC

You cannot simply decide to take the Hawaii Notary Exam and start studying. First, you must meet the minimum eligibility requirements set by the Hawaii Secretary of State. This is a common question covered in any good study guide. You must:

1. Be at least 18 years of age.

Once you have confirmed you meet these prerequisites, you can formally apply to take the exam. The application process involves submitting a form and a fee to the Office of the Lieutenant Governor.

The exam will ask about proper identification methods, acceptable forms of ID, and what to do when a signer is unable to sign their name (they can make a mark).

2. PROHIBITED ACTS AND ETHICS

Hawaii is strict about what a notary cannot do. You cannot give legal advice unless you are an attorney. You cannot notarize your own signature or a document where you are a party. You cannot discriminate against a signer. A strong study guide will highlight these "red flag" scenarios.

3. THE NOTARY JOURNAL AND SEAL

You will be tested on the mandatory requirements for the

notary journal. What information must be recorded? How long must you keep it (usually 5 years after your commission expires)? You will also need to know the specifications for the official notary seal (stamp or embosser), including the required wording and dimensions.

4. FEES AND RECORD KEEPING

Hawaii sets a maximum fee for notarial acts. As of recent regulations, the maximum fee is \$10 per signature for an acknowledgment or jurat. You must be prepared to answer questions about charging fees, travel fees, and the prohibition on charging for a notarial act if you are also the document

preparer.

EFFECTIVE STUDY STRATEGIES FOR THE HAWAII NOTARY EXAM

Simply reading the manual once is rarely enough. To pass with confidence, you need a structured study plan. Here are proven strategies to incorporate into your study routine:

Step 1: Gather Your Official Materials

Book Format

Thinking "it is open book, so I don't need to study" is a recipe for failure. The time limit is tight. If you have to look up every single answer, you will run out of time. You must know the material well enough to answer basic questions quickly and only use the book to confirm tricky details.

**Pitfall 2:
Confusing
Acknowle
dgments**

and Jurats

This is the most common error on the exam. Remember:

- **Acknowledgment:** The person appears before you and acknowledges they signed the document voluntarily. They do not swear to the truth of the content.
- **Jurat:** The person signs the document in your presence after swearing (or affirming) that the content is true.

The exam will present scenarios and ask you which notarial act is required. Pay close

attention to whether the document mentions "sworn to" or "acknowledged before me."

Pitfall 3: Neglecting the Journal Entry Details

The exam may present a sample journal page and ask you to spot an error. Common errors include missing the date of the act, missing the type of identification used, or having the wrong fee recorded. Practice identifying these errors in sample entries.

Pitfall 4: Act" Misunder standing "Certifica te of Notarial

You must know which sections of the law provide the official wording for notarial certificates. For example, a short-form acknowledgment for an individual is different from one for a corporation. The exam may ask you to identify the correct certificate
