SAMPLE BUSINESS LAW CPA EXAM QUESTION AND EXPLANATION

To illustrate the concepts discussed above, here is a sample question similar to what you might encounter on the exam.

Question: A seller offers to sell 100 units of a product to a buyer for \$10,000. The buyer responds, "I accept, but only if you deliver

the units within 30 days." Which of the following statements is correct?

1. A valid contract exists because the buyer accepted the offer.

3. A valid contract exists if the seller delivers the units within 30 days.

Answer A is incorrect because the acceptance was not unconditional. Answer C is incorrect because the seller's subsequent delivery would be an acceptance of the buyer's counteroffer, not the original offer. Answer D is incorrect
