Volumetric Analysis

Common Indicators and Their Selection

The choice of indicator is critical for accurate endpoint detection. An indicator is a weak organic acid or base whose color differs in its protonated and deprotonated forms. The pH range over which the color changes must coincide with the steep portion of the titration curve. For strong acid-strong base titrations, phenolphthalein (colorless to pink, pH

8.2–10.0) or methyl orange (red to yellow, pH 3.1–4.4) are common choices. For weak acid–strong base titrations, phenolphthalein is generally preferred. become less transient. At this stage, add the titrant drop by drop, swirling after each addition. The endpoint is reached when a single drop causes a permanent color change that persists for at least 30 seconds. Record the final volume of the burette. The volume of titrant used is the difference between the final and initial readings. For maximum accuracy, it is standard practice to perform at least three concordant titrations (results that agree within 0.1 mL).

The Mole Ratio Method

For a general reaction:
 $aA + bB \rightarrow \text{products}$,
 where A is the titrant and B is the analyte, the moles of titrant used are calculated first:

Moles of titrant =
 Molarity of titrant $\times$
 Volume of titrant (in
 liters)

Using the balanced chemical equation, the moles of analyte are then determined using the stoichiometric ratio

(b/a). Finally, the concentration of the analyte is calculated by dividing the moles of analyte by the original volume of the analyte (in liters) that was pipetted into the flask.

Normality and Equivalent Weight

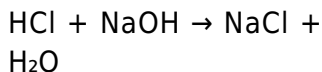
While molarity is the most common concentration unit in modern laboratories, some older texts and industrial applications use normality (N) and equivalent weight. Normality is defined as the number of equivalents per liter of solution. For acid-base reactions, one equivalent corresponds

to one mole of H^+ ions (for acids) or one mole of OH^- ions (for bases). Using normality simplifies calculations because, at the equivalence point, the number of equivalents of acid equals the number of equivalents of base: $N_1V_1 = N_2V_2$.

Consider a scenario where you titrate 25.00 mL of an HCl solution with 0.1000 M NaOH. The average volume of NaOH used from three concordant trials is 22.50 mL. The balanced equation is:



Moles of NaOH =
 $0.1000 \text{ M} \times 0.02250 \text{ L}$
 = 0.002250 moles

Since the mole ratio is
 1:1, moles of HCl =
 0.002250 moles

Concentration of HCl =
 $0.002250 \text{ moles} /$
 $0.02500 \text{ L} = 0.0900 \text{ M}$

Systematic Errors

Systematic errors
