The Integration-Responsiveness Framework

4. **Transnational Strategy:** The most complex and ambitious model. It seeks to simultaneously achieve global

efficiency, local responsiveness, and organizational learning. Knowledge and capabilities are shared fluidly across the network. This is the ideal for many global firms but requires sophisticated management systems and a strong corporate culture. Companies like Unilever and Nestlé strive for this model.
