Requirement 3: Community Leadership and Services

For this requirement, you need to identify community leaders and describe the services they provide. This includes elected officials like the mayor or city council members, appointed officials like the police chief or school superintendent, and volunteer leaders like the head of the local food bank. Each of these individuals plays a role in making the community function smoothly.

Take some time to research who holds these positions in your community. You can visit your city or town website, read the local newspaper, or simply ask a parent or neighbor. Understanding what each leader does helps you see how decisions are made and how you can engage with the system. When you meet with your counselor, be prepared to discuss at least three different leaders and explain how their work impacts your daily life.

Requirement 4: Community Issues and Solutions

This requirement asks you to choose an issue that is important to your community and discuss possible solutions. The issue can be anything from traffic congestion and park maintenance to homelessness or environmental concerns. The goal is not to solve the problem entirely but to show that you understand the issue and can think critically about ways to address it.

Start by paying attention to conversations in your neighborhood or local news. What topics come up frequently? What do people complain about or wish could be different? Once you have identified an issue, research it a bit more. Find out what has already been tried and what barriers exist. Then, brainstorm a few realistic solutions. For instance, if the issue is a lack of recycling options, you might suggest starting a community composting program or petitioning the city for additional recycling bins. Your counselor will be interested in your thought process and your willingness to think creatively about community challenges.

Requirement 5: Attending a Community Meeting

One of the most practical requirements involves attending a meeting of a local government body or school board. This could be a city council meeting, a county commission meeting, a school board meeting, or even a neighborhood association gathering. The purpose is to observe how decisions are made and how citizens can participate in the process.

Before the meeting, take a few minutes to review the agenda. This will help you understand what topics will be discussed. During the meeting, pay attention to how the meeting is run. Who speaks?
