FUNDAMENTAL SOIL PROPERTIES

Particle Size Distributi on

Atterberg Limits

For fine-grained soils like silts and clays, the water content governs their consistency. The Atterberg limits define the boundaries between solid, semi-solid, plastic, and liquid states. The key limits are:

- **Liquid Limit (LL):** The water

content at which soil behaves as a liquid.

- **Plastic Limit (PL):** The water content at which soil begins to crumble when rolled into threads.
- **Plasticity Index (PI):** The numerical difference between LL and PL. A high PI indicates highly plastic clay that is sensitive to moisture changes.

These limits are essential for classification and for predicting compressibility, permeability, and shear strength in fine-grained soils.

SYSTEMS

Engineers use classification systems to group soils with similar behavior. The two most widely used systems are the Unified Soil Classification System (USCS) and the AASHTO classification system. Both rely on particle size and plasticity. In the USCS, soils are designated by two letters: the first indicates the primary component (G for gravel, S for sand, M for silt, C for clay), and the second refines the description (W for well-graded, P for poorly graded, C for clayey, M for silty, H for high plasticity, L for low plasticity). THE PRINCIPLE OF EFFECTIVE STRESS

Perhaps the single most important concept in soil mechanics is effective stress, formulated by Karl Terzaghi, the father of modern soil mechanics. The principle is straightforward but profound: the strength and deformation of soil depend not on the total stress applied, but on the stress carried by the soil skeleton itself—the effective stress. Total stress at any point is the sum of effective stress and pore water pressure. When water fills the voids between particles, it takes a portion of the load.

Only the stress transferred through particle contacts, the effective stress, controls volumetric changes and shear resistance. This principle explains phenomena such as quick sand, slope failure after heavy rain, and settlement of clay layers under loading.

CONSOLIDATION AND SETTLEMENT

When a load is applied to a saturated clay layer, the soil skeleton initially cannot deform because the water in the pores is incompressible. Over time, water is expelled, the void volume decreases, and settlement occurs. This time-dependent process is called consolidation. Understanding consolidation theory is

critical for predicting how much a building will settle and how long that settlement will take. The consolidation test, performed in an oedometer, provides key parameters: the compression index (C_c), the recompression index (C_r), and the coefficient of consolidation (C_v). These parameters allow engineers to estimate both immediate and long-term settlement. Differential settlement, where different parts of a structure settle by unequal amounts, can lead to cracking and structural distress.

SHEAR STRENGTH OF SOILS

Shear strength is the soil's ability to resist sliding along internal surfaces. It is governed

by the Mohr-Coulomb failure criterion, which relates shear strength to effective normal stress and two parameters: cohesion (c') and angle of internal friction (ϕ'). In simple terms, cohesion represents the inherent stickiness of the soil (important for clays), while friction arises from interlocking and sliding resistance between particles (important for sands). The shear strength is measured using direct shear tests, triaxial tests, or unconfined compression tests. Geotechnical engineers use these parameters to assess slope stability, bearing capacity of foundations, and earth pressure against retaining walls. Without a firm grasp of shear strength, none of the

fundamentals of geotechnical engineering can be applied safely.

SITE INVESTIGATION: THE CRITICAL FIRST STEP

No geotechnical design is better than the data on which it is based. Therefore, site investigation is a cornerstone of the discipline. A thorough subsurface exploration program includes drilling boreholes, collecting undisturbed and disturbed soil samples, performing in-situ tests like the Standard Penetration Test (SPT) or Cone Penetration Test (CPT), and establishing groundwater conditions.
